

HOW TO SUBMIT A COMMENT TO THE FCC

RE: *Second Report and Order, Second Further Notice of Proposed Rulemaking in CG Docket Nos. 02-278 and 21-42 and Waiver Order in CG Docket No. 17-59, FCC 23-107 adopted December 13, 2023.*

The Federal Communications Commission (“FCC”) is seeking comment on¹:

Whether and how the Commission can further minimize any potential economic impact on small businesses in complying with our one-to-one consent requirement for prior express written consent under the TCPA?

Are there ways to further clarify or refine this requirement to further minimize any compliance costs?

What impact would such refinements have on consumers?

Are there further outreach efforts or other ways the Commission can assist small businesses in complying with our one-to-one consent rule?

DEADLINE FOR COMMENTS: February 26, 2024

Comments may be filed using the Commission’s Electronic Comment Filing System (ECFS).²

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: www.fcc.gov/ecfs.
- Paper Filers: Parties who choose to file by paper must file an original and one copy of each filing.
- Filings can be sent by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail. All filings must be addressed to the Commission’s Secretary, Office of the Secretary, Federal Communications Commission.
- Commercial overnight mail (other than U.S. Postal Service Express Mail and Priority Mail) must be sent to 9050 Junction Drive, Annapolis Junction, MD 20701. U.S. Postal Service first class, Express, and Priority mail must be addressed to 45 L Street NE, Washington, D.C. 20554.



HOW TO SUBMIT A COMMENT VIA ECFS


STEP 1: Go to www.fcc.gov/ecfs



STEP 2: Select and Click on “Submit a FILING”



STEP 3: Enter the Docket Nos. 02-278 and 21-402 and Select the populated Title (see below)




STEP 4: Enter the Filer Information

STEP 5: Enter the Type of Filing as “Comment”

The additional fields “File Number, Report Number and Bureau ID Number” should be BLANK.
